PRESENTATION: D'Arcangelo: 2022-23 School Year Audit

Tricia Lucas, Partner at D'Arcangelo, presented a summary of the year end financial audit from the 2022-23 school year. Immediately prior to the meeting, Mrs. Lucas met with the Audit Committee and presented a full and detailed report of the financials related to the audit. As part of the board presentation, Mrs. Lucas reviewed the following:

- Statement of revenues, expenditures and changes in fund balance
- Extraclassroom fundraising
- Fund balance: restricted (reserves), assigned and unassigned
- Federal Grant Awards and related expenditures
- Required follow up communication of the audit

In summary, the district ended the 2022-23 favorably and underspent the planned budget by 5%. This was attributed to shifting certain costs from the general fund to take advantage of pandemic relief monies.
